



A Yacht Pass is required for access to a prime location in the Cannes harbour during the Festival. The Yacht Pass is suitable for any company wishing to moor a yacht on the Cannes harbour, right by the main Festival venue, between the dates of 17-24 June 2017. The Yacht Pass is available for €25,000 excluding TVA and includes five Complete Festival passes\*. Please note, the availability of Yacht Passes is strictly limited due to capacity at the harbour, and we cannot guarantee that all requests will be successful. Early booking is strongly recommended. 
\*Please note that the berth cost isn't included in the yacht pass rates. This also needs to be organised and paid. Please go to CCI Rivera Ports <u>website</u> for more information.



Once we have received the completed form you will be given a **Yacht Pass Reference Number.** This number will need to appear on the berth application form. The Yacht Pass includes the following:

- Five x Cannes Lions Complete passes
- Five x Harbour passes (Quai D'Honneur access)\*
- Eligibility to the berth request to the Port of Cannes, on the Quai d'Honneur, by the Palais des Festivals
- Branding and space for a welcome tent: right to position one banner per boat and one welcome tent per boat.

\*Please note that access to the harbour (Quai D'Honneur) will be restricted from 8am to 6pm during the Festival. This area will be accessible exclusively to registered delegates and harbour pass holders.



Fill in the berth application form (you can download it from CCI Riviera Ports website <a href="here">here</a> and post a hard copy to CCI. This procedure is usually done by your yacht broker or captain. Please ensure you give the relevant person your **Yacht Pass Reference Number** as it will need to appear on the application form.

Please be advised that your berth application has to be fully completed in order to be valid.

## **Important information**

- Please be mindful of the official process for berth applications and take care to esure your submission complies with the CCI's procedure in order for your request to be successful.
- Yacht Pass registration and berth application opens on 19 December 2016
- The first deadline for berth applications is 8 March 2017



- Confirmation of berth allocations is 17 March 2017 (for applications sent before 8 March), 21 April 2017 (for applications sent before 11 April 2017) and 19 May 2017 (for applications sent before 10 May 2017)
- Access to the Quai D'Honneur is reserved for Cannes Lions, Lions Health, Lions Innovation and Lions Entertainment delegates, Yacht Pass and Harbour Pass holders from 8am to 6pm between 17 and 24 June 2017.
  - \* Please note that berths availability cannot be guaranteed after 1 May 2017.
